SECTION 2

Requirements for nomination

The nomination should comply with the following in order to be valid:

- a) Only members of the ICFP holding the designation (FP)SA are eligible for election to the Board of the ICFP;
- b) Each director shall hold office for two years from the date of his or her election. Upon completion of his or her two-year cycle, the director shall resign at the next annual general meeting but may stand for re-election.
- c) All reasonable efforts should be made by members to achieve the ideal demographic, geographic and industry representation during the nomination process. The Board shall also attempt to do so if members are co-opted to the Board.
- c) ICFP members who have the right to vote may nominate, within the prescribed period, any number of candidates and may do so for any industry represented on the Board, by sending a completed letter of the nomination via e-mail to the Nominations Committee of the ICFP;
- d) The Nominations Committee, appointed by the ICFP Board, will review all nominations in order to ensure that the candidates are eligible, are not disqualified in terms of the Companies Act or Memorandum of Incorporation, and are in good standing. If a person nominated does not meet the said criteria, the persons who nominated him or her shall be notified in writing.
